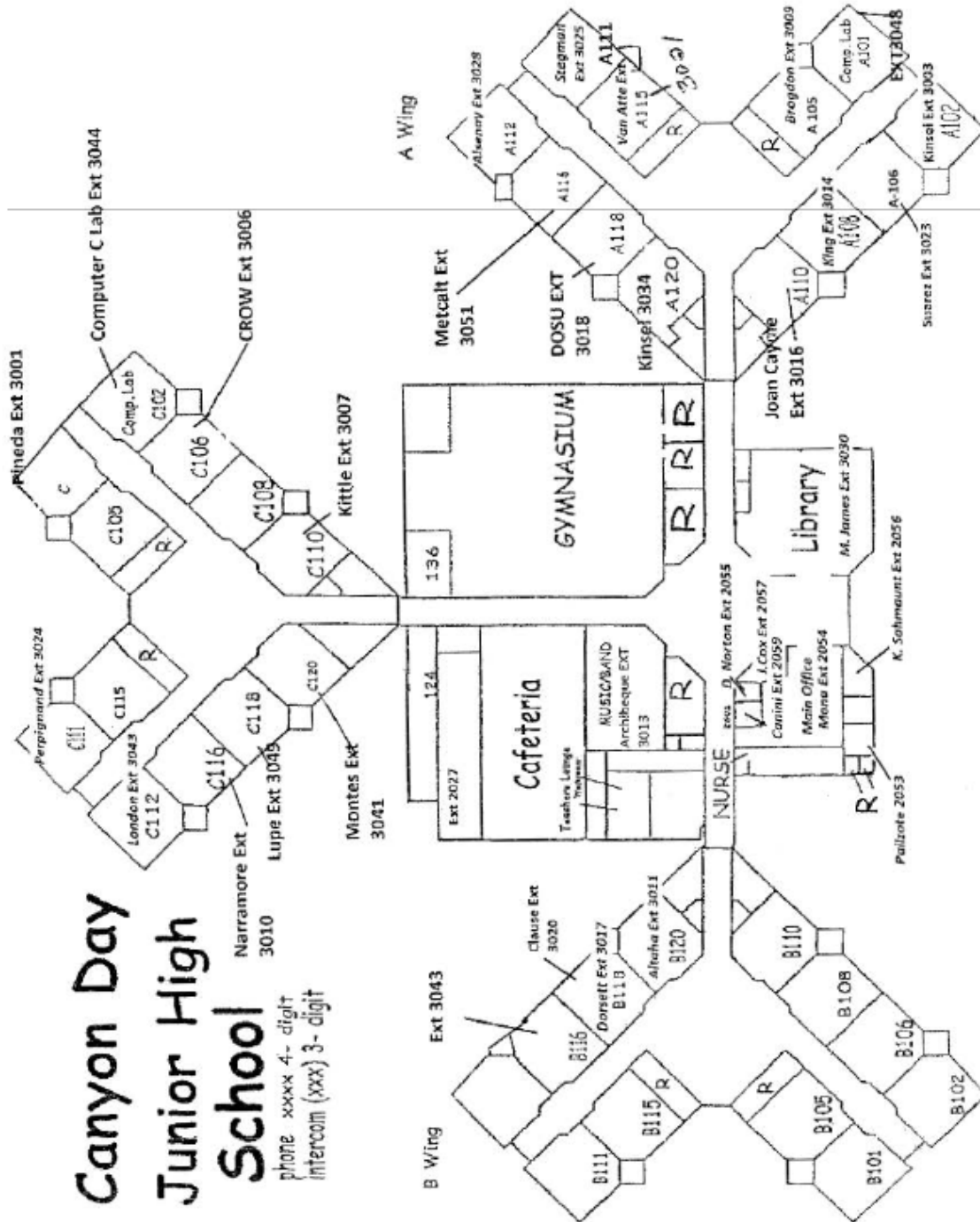
1. Can our Firm attend the preconference via phone or WebEx?

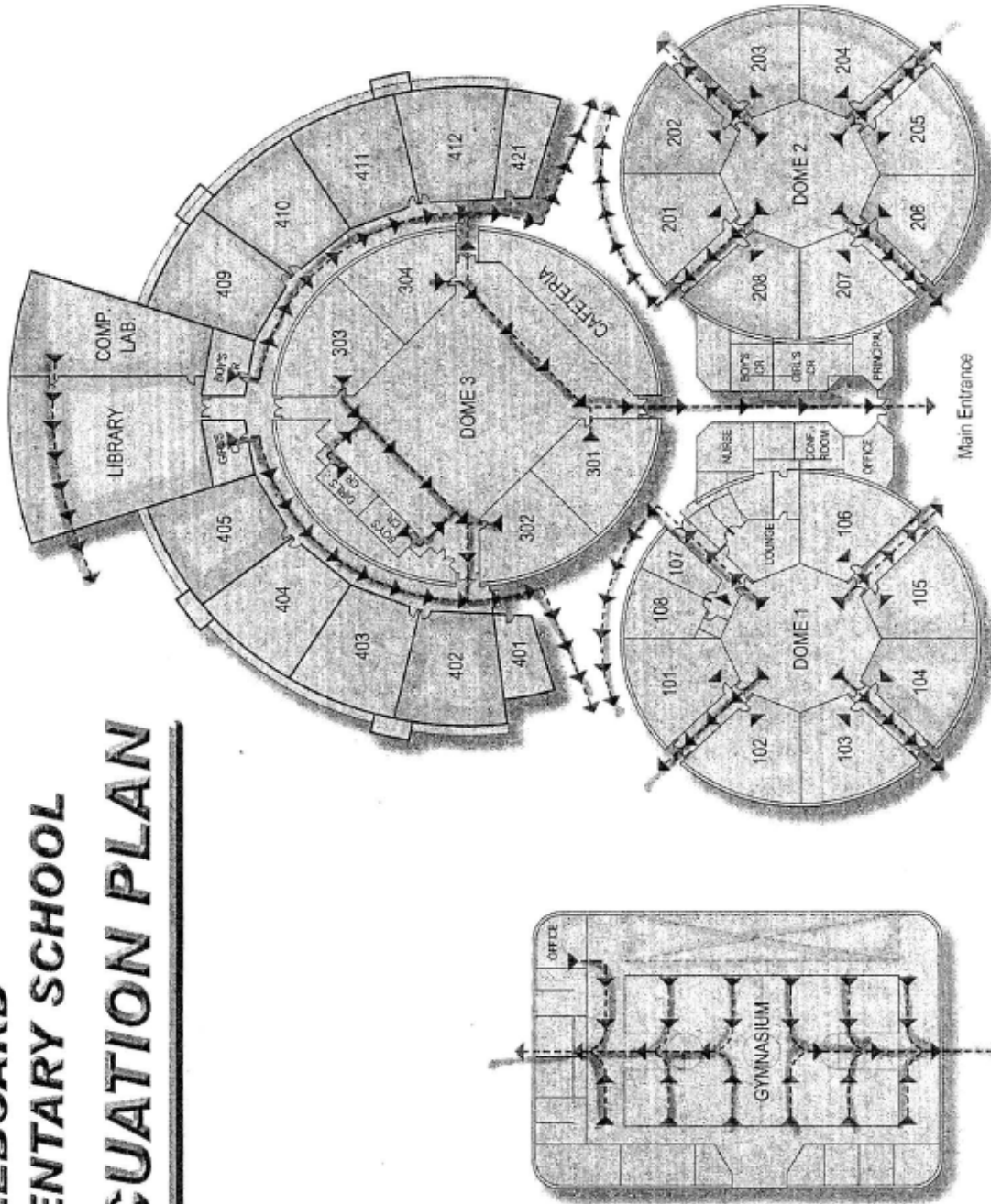

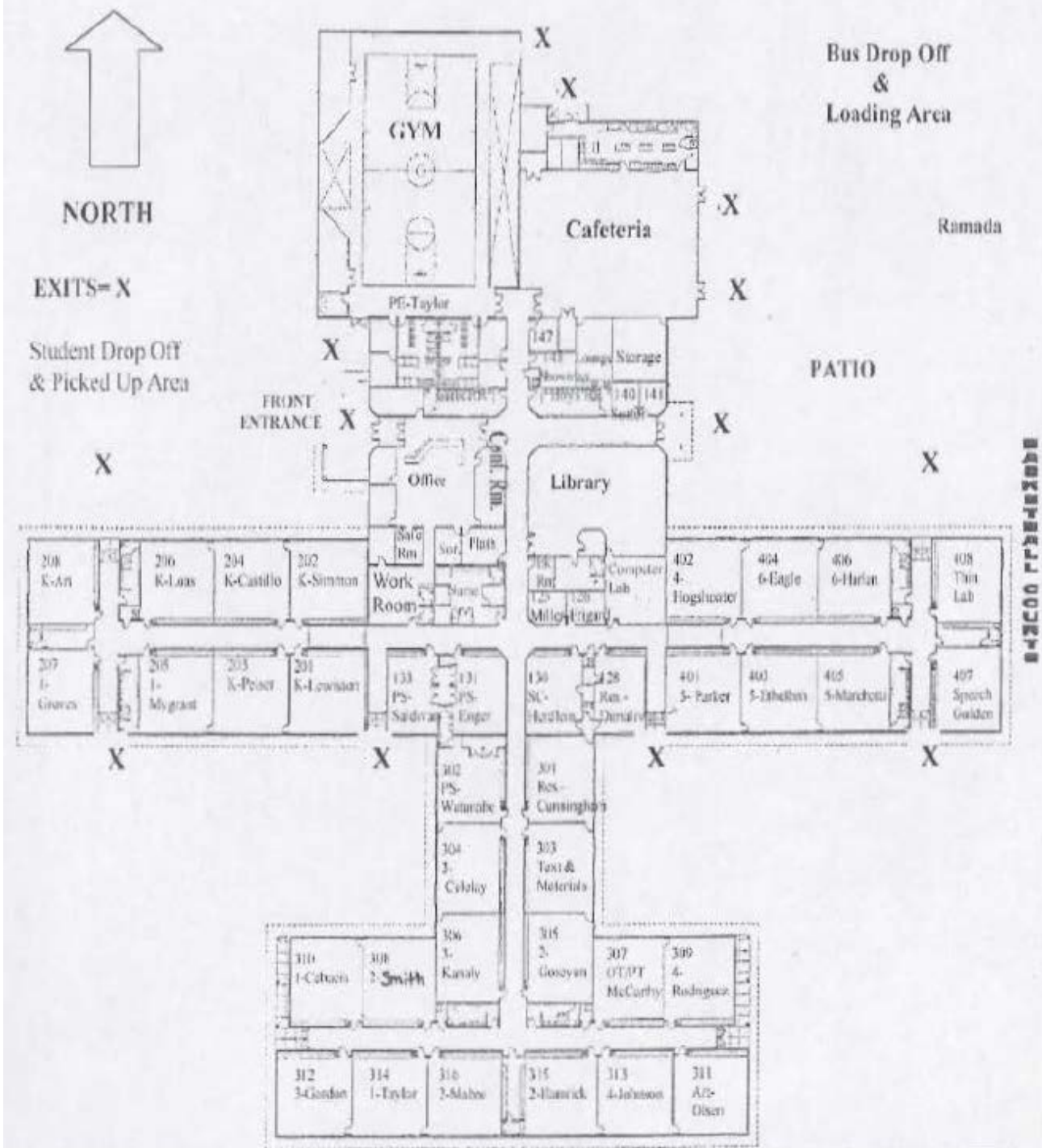
